SEMBCORP WINS CSR TIMES AWARD 2024 FOR URBAN AFFORESTATION

PROJECT IN BHUJ

New Delhi, August 27, 2024 - Sembcorp Green Infra Pvt Ltd (SGIPL), a wholly-owned

Earthquake Memorial Museum in Bhuj using the dense Miyawaki method, a Japanese

afforestation technique. This method involves planting native species in tightly packed,

multi-layered configurations, fostering rapid growth and creating self-sustaining,

biodiverse forests.

The Bhuj afforestation project aims to transform urban wasteland into a dense green

cover, contributing to biodiversity and ecological restoration. The selected mix of fruiting

and non-fruiting saplings, along with native flora, is expected to enhance the city's

microclimate. Over the next 15 years, the plantation is estimated to absorb

approximately 4,700 metric tonnes of carbon emissions.

skills development, health, sustainability, and climate action.
